FOOD ASSESSMENT

THE FOOD ASSESSMENT IS MANDATORY AND WILL BE ADMINISTERED BY THE ASSINIBOINE GOLF CLUB. IF YOU REQUIRE YOUR FOOD ASSESSMENT TO BE ADMINISTERED JOINTLY OR FOR FUTRE CHARGES AFTER ASSESSMENTS ARE USED, PLEASE CONFIRM YOUR ACCOUNT WITH THE RESTAURANT. MUST BE USED PRIOR TO OCT. 31ST OR FORFEITED TO THE ASSINIBOINE GOLF CLUB.

CLUB STORAGE

SEASONAL CLUB STOAGE (BASED ON AVAILABILITY), WILL INCLUDE A HAND WIPED CLEANING AFTER EACH USE. YEAR ROUND CLUB STORAGE IS AVAILABLE – CLUBS WILL REMAIN IN CLUB STORAGE DURING THE OFF SEASON. PLEASE NOT THAT ACCESS TO YOUR CLUBS IS LIMITED AND IS NOT GUARANTEED DURING THE OFF-SEASON. ARRANGEMENTS TO ACCESS YOUR CLUBS DURING THE OFF-SEASON MUST BE MADE WITH THE OFFICE IN ADVANCE. CLUBS ARE STORED AT THE PLAYERS OWN RISK AND ASSINIBOINE GOLF CLUB IS NOT RESPONSIBLE FOR ANY LOSS OR DAMAGE.

CART COMPOUND/TRAIL FEES:

COMBINED CART COMPOUND/TRAIL FEE IS FOR YEARLY POWER CART STORAGE AND UNLIMITED USE OF CARTS ON THE GOLF COURSE FOR THE REGISTERED OWNER (MAX 2) OF THE POWER CART. STORAGE IS AT THE OWNER'S RISK AND ASSINIBOINE GOLF CLUB WILL NOT BE HELD RESPONSIBLE FOR ANY LOSS OR DAMAGES.

CLUB LOCKER ROOM FEE:

CLUB LOCKERS AND TOWELS ARE AVAILABE TO EACH STANDARD MEMBER (BASED ON AVAILABILITY). EACH MEMBER IS REQUIRED TO PROVIDE AN ANNUAL NON-REFUNDABLE \$25.00 LOCKER ROOM FEE.

DISCOUNTS:

THE SPOUSAL DISCOUNT IS AVAILABLE TO THE MEMBER'S FAMILY. THE SENIOR DISCOUNT IS AVAILABLE TO ANY MEMBER 65 YEARS OR OLDER. THE SPOUSAL DISCOUNT IS VALID ON REGULAR PRICED PLATINUM, GOLD OR SILVER MEMBERSHIPS, WHILE THE SENIOR DISCOUNT IS VALID ON **REGULAR PRICED** PLATINUM AND GOLD MEMBERSHIPS.

OTHER:

PLEASE NOTE THAT A MAXIMUM OF 2 GREEN FEES MAY BE CREDITED TOWARDS A MEMBERSHIP. GREEN FEES MUST HAVE BEEN PURCHASED WITH 2 WEEKS PRIOR OF SIGNING AS A MEMBER.

NOTE:

- GOLFING PRIVILEGES ARE NOT AVAILABLE TO ANY MEMBER UNTIL YEARLY MEMBERSHIP DUES ARE PAID IN FULL OR A TIME PAYMENT PLAN IS IN PLACE. ANY DEFAULT OF ANY OF THE PAYMENTS, NSF CHEQUES, AND DENIED CREDIT CARD AUTHORIZATION WILL RESULT IN IMMEDIATE SUSPENSION. MEMBERSHIP MUST BE PAID FOR IN FULL BY JUNE 15TH OF THE CURRENT YEAR.
- FLYING GOLF BALLS CAN CAUSE SERIOUS INJURY. BE ALERT AS A PARTICIPANT OR A SPECTATOR WHEN NEAR TEE OFF AREAS, ON THE GREEN, NEAR PRACTICE AREAS, AND IN GENERAL ALL AREAS OF THE GOLF COURSE. IF INJURED, PLEASE CONTACT THE CLUB OFFICE OR PRO SHOP FOR DIRECTIONS FOR THE CLOSEST MEDICAL ATTENTION. ALL ASSINIBOINE GOLF CLUB MEMBERS, GUESTS, AND GREEN FEE PLAYERS ASSUME ALL RISKS, DANGER OF PERSONAL INJURAY, AND ALL OTHER HAZARDS ARSING FROM BEING ON THE GOLF COURSE AND IN THE CLUBHOUSE. SPECIFICALLY BUT NOT EXCLUSIVELY, THE DANGER OF BEING INJURED BY GOLF BALLS, CLUBS, AND POWER CARTS, OTHER PLAYERS OR SPECTATORS WHEN ON THE PREMISE OF THE ASSINIBOINE GOLF CLUB, IT IS ALSO AGREED THAT THE ASSINIBOINE GOLF CLUB, THE MANITOBA GOLF ASSOCIATION, IT'S OFFICERS, EMPLOYEES, PRO, ALL PRO SHOP STAFF, COURSE SUPERINTENDENT, COURSE STAFF, RESTAURANT STAFF ARE EXPRESSLY RELEASED BY THE MEMBER, GUEST, AND GREEN FEE PLAYERS FROM ANY CLAIMS ARISING FROM SUCH CAUSES.
- THE ASSINIBOINE GOLF CLUB ASSUMES NOT RISK REGARDING STOLEN OR LOST EQUIPMENT.
- TEE TIMES ARE AVAILABLE TO THE PUBLIC WITHIN A 48 HR ADVANCE BOOKING. TO AVOID DISAPPOINTMENT, MEMBERS ARE URGED TO USE THEIR ADVANCE BOOKING PRIVILEGES.
