Terms & Conditions

- Golfing privileges are not available to any member until yearly membership dues are paid in full or a time payment plan is in place.
- Flying golf balls can cause serious injury. Be alert as a participant or a spectator when near tee off areas, on the green, near practice areas and in general all areas of the golf course. If injured, please contact the pro shop for directions for the closest medical attention. All Assiniboine Golf Club members, guests and green fee players assume all risks, danger of personal injury and all other hazards arising from the being on the golf course and in the clubhouse. Specifically but not exclusively, the danger of being injured by golf balls, clubs and power carts, other players or spectators when on the premise of the Assiniboine Golf Club, it is also agreed that the Assiniboine Golf Club, its officers, contractors staff and Assiniboine Golf Club staff are expressly released by the member, guest and green fee players from any claims arising from such causes.
- The Assiniboine Golf Club assumes no risk regarding stolen or lost equipment.
- Food Assessment is required for Play Anytime, Play Anytime Senior & Play Anytime Young Adult Memberships and is applicable to food sales & non-alcoholic beverage sales only. Food assessment balances are administered by the Assiniboine Golf Club and balances must be used no later than September 30th of the calendar year at which point any remaining balances may be forfeited to the Assiniboine Golf Club.
- Seasonal club storage (based on availability), will include a hand wiped cleaning after each use. Clubs must be removed by October 15th of the current year or an additional charge may apply.
- Combined cart compound fee/trail is for yearly power cart storage and trail fees for the registered owner (max. 2) of the power cart. Trail fee is for
 the unlimited use of carts on the golf course. Storage is at the owner's risk and Assiniboine Golf Club will not be held responsible for any loss or
 damages.
- Unlimited gas carts usage is based on availability. Purchase of the unlimited gas cart package secures your seat on a cart and any riding partner is required to pay a full half cart fee. The pro-shop will pair up cart riders to ensure maximum availability of cart inventory. Spousal unlimited gas cart is available to any co-habiting couple and secures your seat on the same cart as your partner. In the event you are riding as a single, any additional riders are required to pay a full half cart fee.
- All fees are non-refundable and non-transferable.
- Any outstanding account balances at the fiscal year end that are not addressed within 10 days of notice to the member may result in forfeiture of the member share.
- Up to 2 green fees may be applied as a credit against the purchase of your membership. Green fees must have been purchased within 2 weeks of signing on as a member.
- Tee times are available to the public with a 48 hr advance booking. To avoid disappointment, members are urged to use their advance booking privileges.
- Juniors playing with members play for free.

Applicable Discounts Terms

- 1st & 2nd Year Play Anytime memberships are already significantly discounted and are not eligible to be combined with any additional discounts.
- Cash Discount may not be applied to any membership paid for using the Time Payment Plan.
- Cash Discount is applicable to any regularly priced adult membership that is paid for in full by cash or by cheque.
- Additional discounts are not applicable on Student Intermediate or Junior Memberships golf fees.
- Regularly price adult memberships may combine cash, senior and spousal discounts if applicable.
- Additional discounts may be applicable for limited time special promotions.

Additional Terms & Conditions for Time Payment Plan

- To setup the Time Payment Plan please fill out the <u>Time Payment Plan Pre-Authorized Debit Agreement.</u>
- Time Payment Plan is available for any golfing membership or league fees that exceed \$500 after fees and taxes (Total Amount Due).
- Time Payment Plan is available via pre-setup withdrawals from your bank account. We do not offer Time Payment via any other payment method.
- Memberships purchased on the Time Payment Plan are required to pay a \$300 payment at the time the membership is purchased (by any
 payment method) with remaining pre-authorized withdrawals commencing the following month on the 15th (or next business day if this falls on a
 weekend) and continue monthly through August 15th.
- Any fees associated with insufficient funds are the member's sole responsibility and under no circumstances will the Assiniboine Golf Club
 reimburse these fees.
- Any stop withdrawal requests must be submitted in writing to the Assiniboine Golf Club Board of Directors via e-mail at board@golfassiniboine.com for consideration.
- If there is a default of a payment, you will have 5 business days from notice to resolve the issue or golfing privileges will be suspended.
- Any outstanding defaulted payments that are not addressed within a month of the original notice will receive a final notice which may result in the
 forfeiture of the member share.
