## Terms & Conditions

- Each Corporate Package will receive 9 Hole Corporate Passes which are fully transferable and can be combined.
- 7 Day advanced booking privileges with no tee time restrictions.
- Depending on the Corporate Membership purchased, you will be entitled to name up to 3 Corporate Card Holders that have additional privileges (see below). Corporate Card Holders will receive a separate card identifying them as card holders.
- Passes expire at the end of the golf season however you are entitled to carry over up to 10 passes on Corporate Memberships or Advertising that is renewed for the subsequent calendar year.
- Lost or stolen Corporate Passes are not the responsibility of the Assiniboine Golf Club.
- For an additional \$25, Corporate Memberships may be paid using our Time Payment Plan. Corporate Memberships that include advertising may also utilize our Time Payment Plan however must pay 50% of their fees at signup to allow us to secure the advertising. - Flying golf balls can cause serious injury. Be alert as a participant or a spectator when near tee off areas, on the green, near practice areas and in general all areas of the golf course. If injured, please contact the pro shop for directions for the closest medical attention. All Assiniboine Golf Club members, guests and green fee players assume all risks, danger of personal injury and all other hazards arising from the being on the golf course and in the clubhouse. Specifically but not exclusively, the danger of being injured by golf balls, clubs and power carts, other players or spectators when on the premise of the Assiniboine Golf Club, it is also agreed that the Assiniboine Golf Club, its officers, contractors, contractor staff and Assiniboine Golf Club staff are expressly released by the member, guest and green fee players from any claims arising from such causes.
- No share purchase is required however Corporate Card Holders may purchase a share (\$100) if they would like voting privileges.
- The Assiniboine Golf Club assumes no risk regarding stolen or lost equipment. All fees are non-refundable and non-transferable.
- Any Corporate Card Holder outstanding charge account balances must be cleared by October 15<sup>th</sup> of the calendar year
- Tee times are available to the public with a 48 hr advance booking. To avoid disappointment, corporate pass holders are urged to use their advance booking privileges.

### Corporate Card Holder Additional Privileges

- As a Corporate Card Holder we want you to feel at home as a member. The following privileges will be extended to you as a Corporate Card Holder:
  - Play in all Member Events including Opening, Closing, Club Championship, 4 Ball, Novelty Events & more\*\*
  - Play in all Leagues including Men's Night, Ladies League, Mundie Putter, Ladies Nassau, Senior Central\*\*
  - Eligible for all discounts and promotions that are available for regular AGC members
  - Access to the Golf Canada Handicap tracking system to track your golf handicap
  - Access to purchase additional facility amenities (club storage, lockers, unlimited gas cart package etc) @ 25% off
  - Access to setup an account for member charging privileges (\$100 deposit required for initial setup)
  - Waived facility rental fee for booking catered functions in the restaurant
- In addition to extending AGC Member benefits to each Corporate Card Holder, we will also provide each corporate card holder with the following fully transferable package inclusions:
  - 5 x 50% Gas Cart Coupons
